Mercer University, a private, nonprofit college in Georgia recently partnered with CTM and has already received bookings. "The special rates and waived fees are now available at select Maconarea hotels and soon will be offered at hotels near Mercer's other campuses in Atlanta, Savannah and Columbus," said Ken Boyer, associate vice president for auxiliary services. "The discount can vary depending on room availability but can typically range from 5% to 15%," he said.

"It's really for anybody that's visiting the University — parents, prospective students, people coming in for concerts at The Grand Opera House, athletic events, you name it," Boyer said.

MCAG is excited to announce that a major milestone has been reached in the Visa/Mastercard Settlement. The court that oversees the case set a deadline of July 24th for any appeals to be filed to the United States Supreme Court. That date has passed, and the parties are currently preparing to administer the claims process. In addition to this important news, just last week, the Judge in this case appointed a Special Master to resolve any issues relating to the Plan of Administration and Distribution for this settlement.

#### What Does This Mean for You?

Finalizing the settlement is one of the last hurdles before a notice and claim form can be sent to class members, which triggers the start of the claim filing period.

PLEASE NOTE: When claim forms become available, MCAG clients will not have to complete or submit any documents—MCAG will handle the claim submission on your behalf.

#### What Do You Need to Do?

If you are not yet an MCAG client, there is still time to enroll. Eliminate the need to review settlement documents, track important dates, and gather, analyze, and submit claim forms. Let seasoned industry experts work on your behalf on the Visa/MC settlement AND future settlements for which you qualify as a class member.




