## DON'T MISS THE \$5.54 BILLION VISA MASTERCARD SETTLEMENT DEADLINE!

If your campus accepted Visa or Mastercard payments from January 1, 2004, to January 25, 2019, you may be eligible to recover significant funds from a pending settlement, but you must submit a claim by February 4, 2025 to the Settlement Administrator or have a claim submitted on your behalf.
